

## **“Mother’s Day Giveaway”**

### **Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.**

**1. ELIGIBILITY.** “Mother’s Day Giveaway” (the “Sweepstakes”) is only open to Entrants who, as of the entry date, are permanent legal residents of the States of Minnesota, North Dakota, South Dakota, Iowa, Illinois, or Wisconsin who are at least eighteen (18) years old (“Entrants”). The Sweepstakes is void outside of the States of Minnesota, North Dakota, South Dakota, Iowa, Illinois, and Wisconsin and where prohibited or restricted by law. Employees, officers and directors of the Saint Paul Arena Company, LLC (“SPAC”), and their respective parents, subsidiaries, affiliates, divisions, advertising and promotion agencies, and the immediate families (defined as parents, spouses, children, siblings, grandparents, and their respective spouses) or members of the same household (whether related or not) of each such employee, officer and director, are not eligible to enter. The Sweepstakes, and any website pages and advertisements relating thereto, is intended for viewing only within the eligible Sweepstakes territory, and Entrants must be present in the eligible Sweepstakes territory at the time they enter.

**2. TIMING.** The Sweepstakes entry period begins at 4:30 p.m. Central Standard Time (“CST”) on May 5, 2026, and ends at 12:00 p.m. CST on May 8, 2026 (the “Entry Period”). SPAC’s computer is the official timekeeping device for the Sweepstakes.

**3. HOW TO ENTER WITH OFFICIAL RULES.** There are two (2) ways to enter this Sweepstakes. Limit one (1) entry per person. Additional entries beyond the specified limit, and any entries that do not comply with these Official Rules, will be void.

(i) To enter via website, Entrant must (a) have a valid email address and (b) during the Entry Period, submit entry through the Sweepstakes entry form at <https://www.grandcasinoarena.com/contests/detail/mothers-day-giveaway>. By successfully following sweepstakes rules, as directed, Entrant will receive one (1) entry in the Sweepstakes. The time of receipt of any valid form submission shall be the time such valid entry becomes available to SPAC. In the event of a dispute about entries submitted by multiple individuals using the same email address, entry will be deemed to have been submitted by the authorized holder of the email account used to enter the Sweepstakes at the actual time of entry. All information Entrants submit in connection with this Sweepstakes and agree to share with and will be treated in a manner consistent with the Saint Paul Arena Company’s Privacy Policy accessible at: <https://www.GrandCasinoArena.com/privacy-policy>.

(ii) To enter via Mail, limit one (1) mail in entry per person and address (physical or email) in the Sweepstakes. All entries must be received by SPAC during the Entry Period and become the exclusive property of the SPAC. Entries will not be acknowledged or returned. All Entrants and entries are subject to verification prior to the awarding of a prize, as are the eligibility, age, and other claims of/information provided by a potential prize winner. **4. COMPLIANCE WITH OFFICIAL RULES.** Failure to submit all required information in the manner required in these Official Rules may result in disqualification. Proof of submission will not be deemed to be proof of receipt by SPAC. Any submission that does not comply with any aspect of these Official Rules may be rejected by SPAC and the Entrant disqualified.

**5. AGREEMENT TO OFFICIAL RULES AND DECISIONS.** By participating in the Sweepstakes, each Entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of SPAC (including, without limitation, decisions regarding eligibility of entries, the selection of Entrants and the winners, and the awarding of prizes), which are final and binding in all respects.

**6. SELECTION OF WINNING ENTRY; ODDS; NOTIFICATION.** On or about May 8, 2026, SPAC, in its sole discretion, will select one (1) winner(s) from all eligible entries received. Odds of being selected depend on the number of eligible entries received by SPAC during the Sweepstakes. The winner-select must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. Each potential winner will be notified via email by a SPAC representative (the "Prize Notification") and will be required to privately (via email message, phone, or other secure means, as applicable) confirm his/her name, address, age and other personal information necessary, as well as may be required to execute an Affidavit of Eligibility and Release of Liability and Publicity, in order to receive a Prize. In the event that any potential winner does not respond to any such Prize Notification within forty-eight (48) hours of the first attempt to contact, then potential winner may be disqualified and an alternate winner may be selected by SPAC from all eligible non-winning entries received by SPAC during the Entry Period.

**7. PRIZE.** Subject to the terms and conditions of these Official Rules, one (1) prize will be awarded to one (1) winner during this Sweepstakes. Prize must be accepted as awarded, and prize is awarded "AS IS" with no warranty, representation, or guarantee, express or implied, in fact or in law, made by SPAC or for which SPAC shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR

PURPOSE. No substitution, assignment, refund or transfer of a prize is permitted, except by SPAC, who reserves the right to substitute a prize (or a component thereof) with another prize (or component thereof) of greater or equal value, including cash, if a prize is not available for any reason as determined by SPAC in its sole discretion. Winner is solely responsible for any and all costs, fees, taxes and expenses associated with prize award, receipt and use, including, without limitation, all federal, state and local taxes associated with the prize and any travel required to collect the prize. If applicable, prize winner will be issued an IRS Form 1099 for the retail value of the prize. LIMIT: One (1) prize per person or address (physical or email) in this Sweepstakes.

**8. MOBILE DISCLOSURE.** If you opt to use your wireless mobile device in connection with this Sweepstakes, depending on your phone's capabilities, standard messaging and data rates may apply according to the terms and conditions to your service agreement with your wireless carrier. Wireless carriers' rate plan may vary.

**9. PUBLICITY.** Except where prohibited by law, participation in the Sweepstakes constitutes Entrant's consent to SPAC's (and their respective designees', successors' and assigns') use of Entrant's name, biography, likeness, voice, photographs, video, opinions, statements, hometown, state and country for promotional purposes in any manner or media (including, without limitation, online), worldwide, in perpetuity, and without further payment, consideration, notice, review or consent.

**10. GENERAL CONDITIONS.** Entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be disqualified. Entries containing offensive, obscene, derogatory, lewd, or other inappropriate content, as determined by SPAC in its sole discretion, are prohibited and will be disqualified. SPAC reserves the right, in their sole discretion, to terminate, modify or suspend the Sweepstakes if, in their opinion, there is any suspected or actual evidence of electronic or nonelectronic tampering with any portion of the Sweepstakes, or if viruses, bugs, unauthorized intervention, fraud, technical difficulties or failures or any other factor beyond SPAC's reasonable control corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes. In such event, SPAC reserves the right (but do not have the obligation) in their sole discretion to award a prize at random from among eligible, non-suspect entries received up to the time of suspected impairment. SPAC reserves the right in their sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately damage any website or undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws, and, should such an attempt be made, SPAC reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. SPAC's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision or any other provision of these Official Rules.

**11. RELEASE.** By entering, each Entrant forever and irrevocably releases and holds harmless SPAC, their respective parents, subsidiaries and affiliates, and their respective agents, advertising and promotion agencies, affiliates, Sweepstakes partners and prize suppliers, and all of their respective employees, officers, directors, shareholders and agents from and against all claims, damages or

liabilities arising in whole or in part, directly or indirectly, from Entrant's participation and/or entry in the Sweepstakes and/or Entrant's award, receipt or use of any prize awarded in the Sweepstakes.

**12. LIMITATIONS OF LIABILITY.** SPAC is not responsible for: (a) incorrect or inaccurate transcription of entry information or late, lost, stolen, unintelligible, illegible, damaged, mutilated, altered, incomplete, misdirected or postage due entries or entries received through impermissible or illegitimate channels, all of which will be disqualified; (b) technical failures of any kind, including but not limited to the malfunctioning of any telephone, computer online systems, computer equipment, website, server provider, network, hardware or software; (c) the unavailability or inaccessibility of any website or service; (d) unauthorized intervention in any part of the entry process or the Sweepstakes; (e) printing, typographical, electronic or human errors which may occur in the offer or administration of the Sweepstakes or the processing of entries; or (f) any injury or damage to persons or property, including but not limited to Entrant's computer, which may be caused, directly or indirectly, in whole or in part, from Entrant's participation in the Sweepstakes, or from viewing, playing or downloading any material from the SPAC's website(s), regardless of whether the material was prepared by SPAC or a third party, and regardless of whether the material is connected to SPAC's respective websites by a hypertext link.

DISPUTES.** Entrant agrees that: (a) any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes, or any prizes awarded shall be resolved individually, without resort to any form of class action, and solely and exclusively in a federal or state court located in Minneapolis or St. Paul, Minnesota; Entrant submits to sole and exclusive personal jurisdiction to said courts in the State of Minnesota for any such dispute and irrevocably waives any and all rights to object to such jurisdiction; (b) any and all claims, judgments, and awards shall be limited to actual out of pocket costs incurred, including costs associated with entering this Sweepstakes but in no event attorneys' fees; and (c) under no circumstances will Entrant be permitted to obtain awards for and Entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of Entrant or the SPAC in connection with the Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of Minnesota, without giving effect to any choice of law or conflict of law rules of provisions (whether of the State of Minnesota, the United States, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Minnesota.

**14. DATA COLLECTION.** Entrants provide personal information on the entry form when they enter this Sweepstakes. SPAC collects this information and uses it to (a) administer this Sweepstakes, (b) for market research and (c) for other marketing purposes. If Entrant enters the Sweepstakes, Entrant elects to "opt-in" to receiving marketing or promotional communications from SPAC and/or its marketing partners. Entrants may "opt-out" of receiving such marketing or promotional communications by

stating on the entry form that Entrant does not desire to receive such communications. Consenting to receive such emails and information (by not "opting-out" or by "opting in") is optional, and is not necessary to enter or win this Sweepstakes, nor will it increase or improve Entrant's chances of winning.
